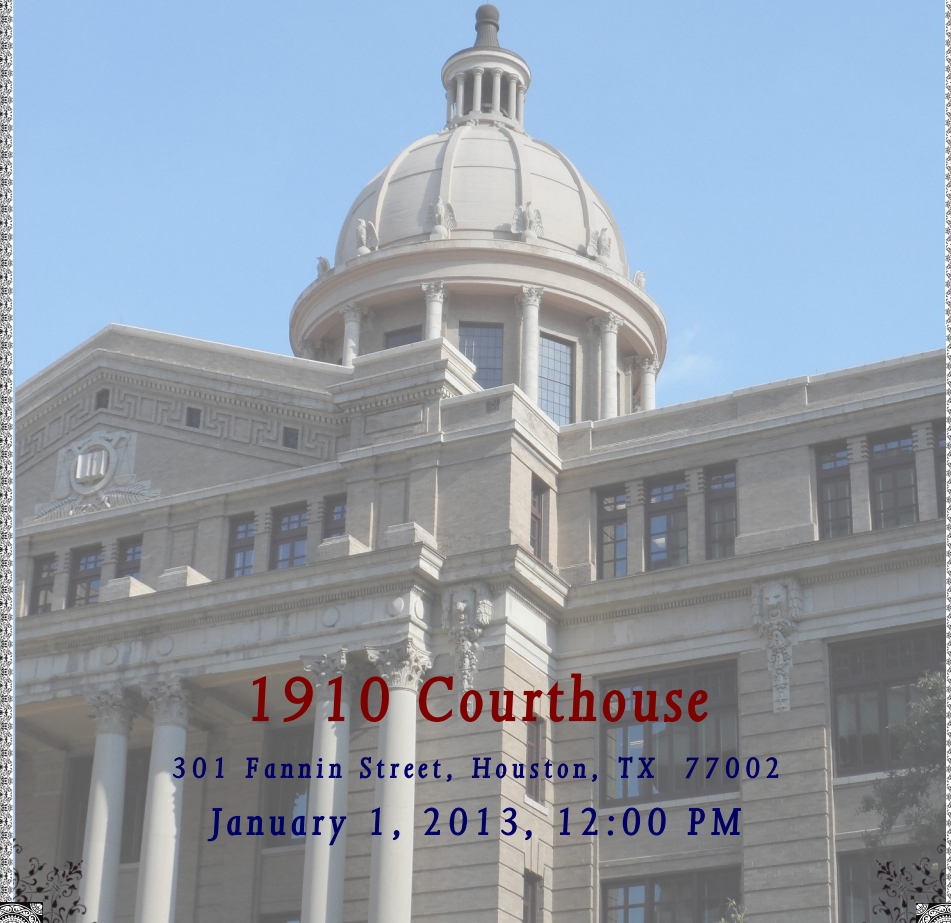

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS, I, "Newly Elected Official", do solemnly swear (or affirm), that I will faithfully execute the duties of the office of "Elected Office", of the State of Texas, and will to the best of my ability preserve, protect, and defend the Constitution and laws of the United States and of this State, so help me God.

I solemnly swear (or affirm) that I have not directly or indirectly paid, offered, promised to pay, contributed, or promised to contribute any money or thing of value, or promised any public office or employment for the giving or withholding of a vote at the election at which I was elected or as a reward to secure my appointment or confirmation, whichever the case may be, so help me God.
