There has been a change to our procedures. Please **READ CAREFULLY.** The Committee for Qualified Counsel in Death Penalty Cases has approved the enclosed Application to be Maintained on the List of Attorneys Qualified for Appointment in Death Penalty Cases in the Eleventh Administrative Judicial Region of Texas. This is only if you wish to maintain your current status. If you wish to add a category, you must complete a new application for that category.

The new application must be **notarized** and must include CLE that clearly indicates **20 hours of Death Penalty CLE.**

Please complete the application and the Attorney Contact Information Form (if there is a change to your contact information.

You should report your CLE hours by printing the <u>Transcript Report</u> from the Texas Bar webpage (View/Report MCLE hours then View Transcript Report and use **date range for previous 2 years** from the date application is signed.) Please specify the CLE hours relating to death penalty by **PLACING A CHECK MARK** next to the applicable hours. A highlighter should <u>NOT</u> be used as it may not show up on copies or scans. If THE COURSE name does not specify **Capital or Death** Penalty, **YOU MUST indicate how many hours of that specific course applied directly to Death** Penalty **cases**. All self-study needs to be explained as to what it was and how it applies to death penalty cases.

Therefore, in compliance with the provisions of Article 26.052, Texas Code of Criminal Procedure, I swear or affirm that I meet the following standards promulgated by the Local Selection Committee :

- 2. □I remain qualified for appointment in death penalty cases pursuant to the Standards for Qualification of Attorneys for Appointment Death Penalty Cases, as adopted and revised by the Local Selection Committee for the 11th Administrative Judicial Region of Texas.
- 3. I have not been found by a federal or state court to have rendered ineffective assistance of counsel during the trial or appeal of any criminal case nor have I filed documents admitting that I have rendered ineffective assistance of counsel in any criminal case.

I request a waiver of the requirement and have attached documentation in support of the request.

4. I have participated in continuing legal education courses or other training relating to criminal defense in death penalty cases approved by the Presiding Judge for MCLE for at least twenty hours (of which no more than five hours may be self-study) within the previous two years¹ [Attach proof of CLE, specifying which portions of the CLE course(s) relate to criminal defense in death penalty cases and the number of CLE hours for those portions of the CLE course(s) and <u>include description of any self-study course</u>].

¹Attorneys placed on the list of attorneys qualified for appointment as 1st chair counsel will also be placed on the list of attorneys qualified for appointment as second chair.

² Determination of whether an attorney has satisfied the CLE requirements of the Local Selection Committee shall include whether the attorney has, in the past year from the date of application to be Qualified Counsel, satisfied the minimum CLE requirements promulgated by the State Bar of Texas, including three hours of Legal Ethics. See Texas Code of Criminal Procedure Art. 26.052(d)(5) and State Bar Rules Article XII, Section 6(B).
